- Submit a Scholarship Application, which includes approval from your Supervisor/WIC Coordinator or Director to ensure your participation does not interfere with the provision of WIC services.
- Include a Personal Statement supporting your interest in your participation and what you hope to gain from attending the conference or training. What benefit will your WIC program receive by your participation?
- If awarded the scholarship, provide a short "WIC Client Story" with picture (if possible) about how WIC had a positive impact. (This can be your own story, or with permission, the story of a current or past client). WIC stories will be shared during visits to Congress and Senate. Due: February 15, 2019.
- For travel and conference expenses not paid directly by Nutrition First, you will need to submit an expense request with receipts within 30 days of the conference.
- After the conference, submit a synopsis of some high points of the conference and one concept, idea, or tool that you learned that you can put into practice within 30 days of the conference. This synopsis may be used on Nutrition First website and in a future newsletter.
- You agree to attend the full conference and accompany the Nutrition First delegation on visits with members of the Congress and Senate.

Applications must be received by 5pm January 15, 2019. Applications may be scanned and submitted through e-mail, or mailed to PO Box 425, Conway, WA 98238.
